

- iv. She will not be allowed to stay abroad more than the approved period;
- v. Immediately after completion of her Master course, she will return to the country and submit report to the Secretary of Planning Division within 5 (five) days;
- vi. She will follow the terms and conditions of the executed bond.
- v. This order will also be treated as no-objection certificate regarding her staying in abroad following the above mentioned terms and conditions.


